

Taxation Appeals concerning land

Under Section 46D of the Taxes Management Act 1970 appeal lies to the Lands Tribunal from certain decisions and assessments of the Inland Revenue in which the question at issue is the value of any land. For procedure see **Lands Tribunal Rules 1996** and **Procedure**.
